[1] SVMC § 9-5A-3.C: Staff has 30 (maximum of 60) days to review applications for completeness and request additional materials as necessary.

[2] SVMC § 9-5A-7.B: At least 15 days prior to the public hearing, the city shall mail notices to adjacent owners and publish notice of the hearing in the newspaper.

[3] SVMC § 9-5A-7.C: The Commission hearing shall be conducted within 90 days of a certified complete application.

[4] There will only be one scheduled meeting in each of January, February, August, October, November, and December. Meetings may be cancelled due to lack of applications.
